
Errors in the book <u>Vital record of Rhode Island 1636-1850</u>, by James N. Arnold, have led to much misinformation for Benjamin Brand. FamilySearch's records mirror what is in Arnold's book. It appears FamilySearch used the book to create their <u>Rhode Island Births and Christenings</u>, 1600-1914 records. The images on said birth records only redirect you to unindexed Film #930813 found in <u>Town meeting and vital records vol. 2-4 1706-1819</u>, Westerly, Rhode Island. One must find the actual record themselves. In other words, it does not appear FamilySearch reviewed the primary records when creating the Rhode Island Births and Christenings, 1600-1914 collection.

Primary records reveal that Benjamin Brand and Rebecca, his wife, had a son named Amos. Furthermore, Benjamin Brand and Lucy, his wife, had three children: Rebecca, Benjamin, and David. There is no record of the alleged daughter, a twin, named Lucy.


Their marriage and children's birth information are recorded in the same entry. Amos is the only child named. This entry does not continue on the next page.

Benjamin Brand married Lucy Cottrell in 1740



Misinformation in book titled Vital record of Rhode Island: 1636-1850

Numerous errors are found for Brands in <u>Vital record of Rhode Island: 1636-1850</u>: first series: births, marriages and deaths: a family register for the people by Arnold, James N. (James Newell), 1844-1927. Note that I only reconciled original records in Vol 1-2 against Arnold's book. I did not check the accuracy of original records in Vol 3 verses Arnold's book.




